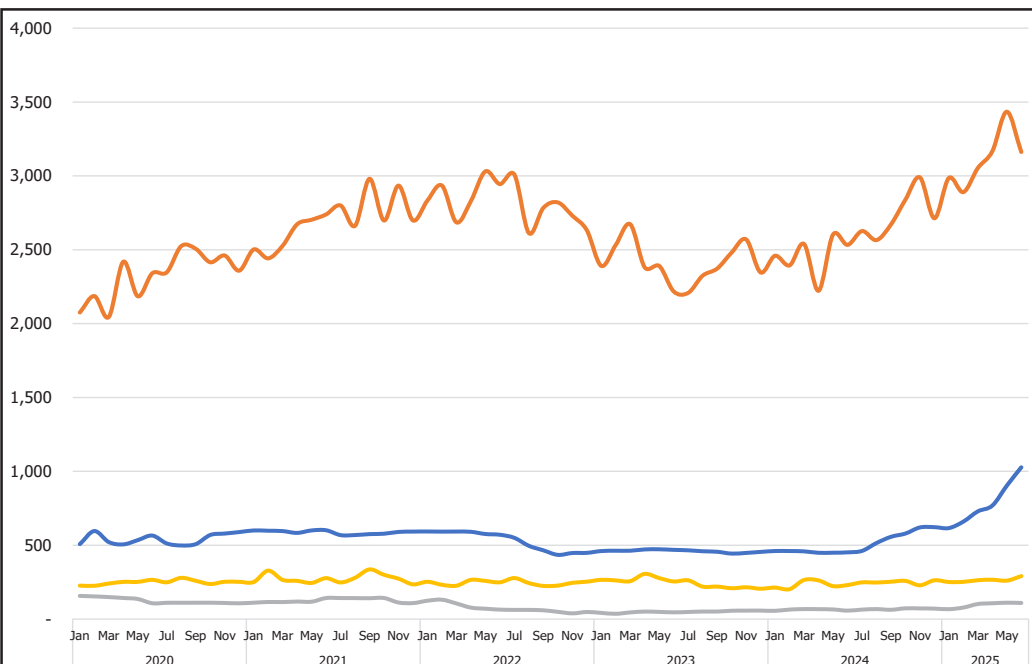
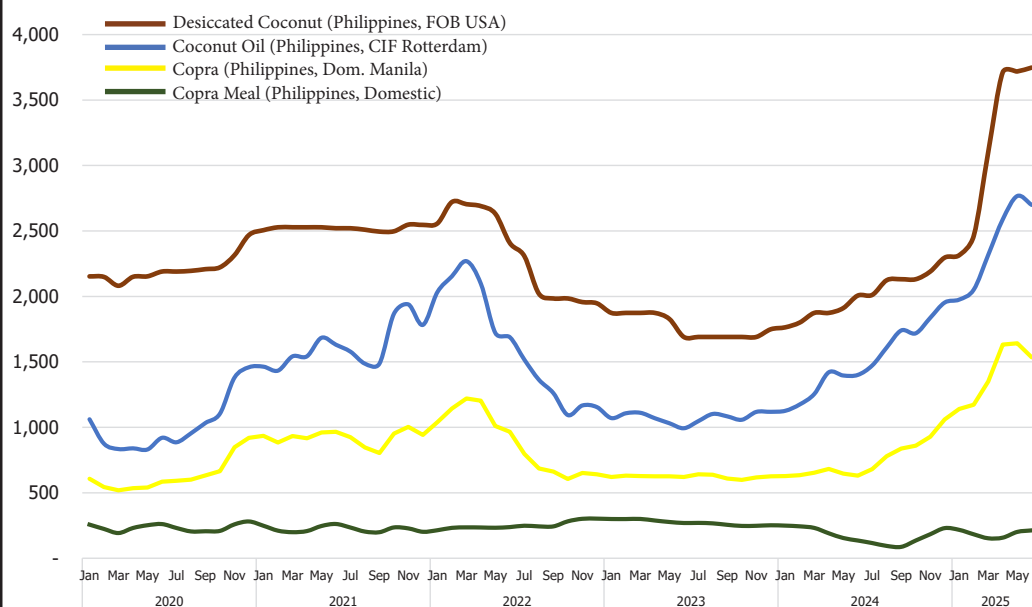

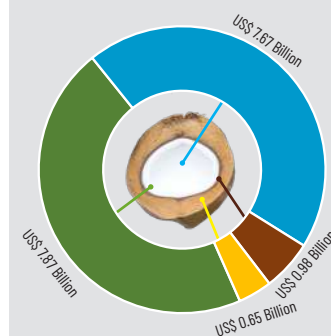

PRICES OF KERNEL PRODUCTS, 2020 - 2025 (USD/MT)



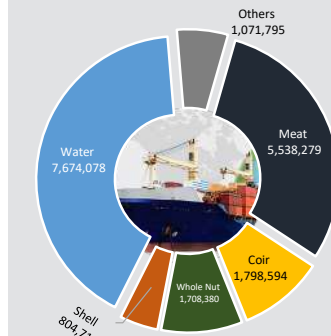
Global Export Value, 2024
